## BOOKING CONDITIONS

Please read the following conditions very carefully as they form the basis of the contract between ourselves and all those on the booking form on whose behalf the party leader is acting.

### Pricing:

Prices are per person on a basis of two people sharing a room. They include 7 nights accommodation, 7 breakfasts and afternoon tea and a 3 course evening meal with wine on 6 days. Prices DO NOT include travel costs (i.e. flights, car travel, ferry crossings or transfers to the resort) insurance, lift passes, ski lessons and any ski and boot hire.

### Booking and paying:

After your enquiry we will hold a provisional booking for 7 days until we receive a fully completed and signed booking form together with a deposit of 150 euros per person. We will then send you a confirmation and an invoice. The balance of payment including any extras (i.e. lift passes, ski hire etc) as shown on your confirmation will be due 8 weeks before departure. If booking within 8 weeks of departure the full amount will be due when booking. Failure to pay the full balance at this time may be considered as a cancellation on your part.

### Insurance:

All persons booking a holiday are required to purchase insurance to cover the cost of cancellation by you or the cost of assistance and repatriation in the event of accident or illness. If you do not have cover Morzinewise shall in no way be responsible for any charges or matters arising as a result.

### Alterations and cancellation by you:

Any changes to your arrangements, once confirmed with us, should be notified in writing by the group leader. Should you or any member of your group need to cancel your holiday, once confirmed, the group leader must immediately advise

us in writing. From the date we receive that written notice cancellation charges will be applicable as set out below;

#### Alterations and cancellation by us:

In the case of any minor or significant changes we should have to make to your holiday you will be notified at the earliest possible date. In the event of a significant alteration, you may accept it or cancel your holiday and receive a full refund, although we will pay no extra compensation.

#### Force majeure:

We regret we cannot accept liability or pay any compensation where the performance of our contractual obligations is prevented or affected by 'force majeure'. In these booking conditions 'force majeure' means any event in which we or the supplier of the service(s) in question could not, even with all due care, foresee or avoid. Such events may include war or threat of war, riots, civil strife, terrorist activity, industrial dispute, natural or nuclear disaster, adverse weather conditions, fire and all similar events outside our control.

#### Resort taxes:

The local council applies a nightly tourist tax for all those aged 16 and over, this is included in your holiday price.

#### Resort prices:

Any prices given for activities, ski passes, ski lessons and ski packs were correct at the time of publication. We cannot accept any responsibility for any variation between that time and the date of your holiday. These services are provided subject to the conditions of the relative suppliers, some of which may limit or exclude their liability to you. Copies of their conditions are available from each supplier in question.

#### Passport, visa and health requirements:

We cannot accept any liability if you are refused entry onto a flight or into any country due to failure on your part to carry the correct passport, visa or other travel documents required by any airline or authority. Requirements may change and you should check the up to date position with the passport office. Before travelling you are advised to check with your own doctor for your own medical requirements.

#### General conditions:

The chalet is normally available from 15.00 hours on the day of your arrival and you should be prepared to check out around 10.00 hours on day of departure. If for any reason you should arrive before or leave after these times we shall do everything in our means to accommodate this.
